Description

SovereignDeepkill provides a means of delivering highly active fungicides and insecticides in areas where deep penetration is required.

On application of the paste, a skin is formed which prevents evaporation of the carrier solvent, maximising the uptake of active material into the timber.

Properties

Used for the curative and preventative preservation of timber from wood destroying fungi and wood boring insects.

Preparation

Ensure timber is free from any dirt or debris, and that any coatings have been removed.



USAGE

Can be applied using a Deepkill Gun, brush or palette knife. Gun beads of Deepkill at 3" (75 mm) centres onto the timber. This is especially useful for large cross section timber.

For thin-sectioned timber apply as required with a brush etc.

Care should be taken to prevent contamination of adjacent plaster.

GENERAL MAINTENANCE

No further maintenance regime is required after application. However general building maintenance is required to prevent water ingress.

GENERAL

Can be used on all types of soft and hard wood. Particularly useful for thick sectioned timber such as floor joists and roof supports, especially timber fixed into wall sockets that are not protected with a membrane.

Timber once treated with Deepkill is suitable for receiving decorative coatings such as paints and stains, as on drying no residue will remain.

CLEAN UP

Tools can be cleaned with a mix of strong detergent and water. Otherwise white spirit may be used.

1.25 m² per litre.

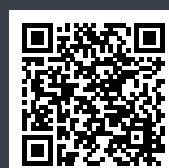
